Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 3 (1 sections each in Bal Vatika I, II & III respectively) and total number of sections from classes I to X shall be restricted to 10. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation Bye law and availability of class rooms of greater than 500 ft dimensions.
2	The ground is not bound by the walls as per guidelines of the Board the school shall be bounded with the 6ft. School is directed to bound the school with six feet concrete boundary walls from all sides and submit the videographic compliance within 03 months.
3	Composite Science Lab is not established properly. Equipment are placed on wooden table, proper workstation are not developed as per SoP of the Board. Heating burner/gas supply, electric connection and sufficient sinks are not available. School is directed to develop the composite Lab as per SoP given in the circular 11/2022 and submit the videographic compliance within 03 months.
4	Outdoor sports facility is not developed properly as per SOP prescribed in circular no. 11/2022. Ground is temporary marked. School is directed to develop the field and sports facilities as per SoP given in the circular 11/2022 and submit the videographic compliance within 03 months.
5	Work of Lift is under construction. School is directed to complete the construction work/installation of Lift and submit the videographic compliance within 03 months.
6	School is running the indoor activities as rehearsal, yoga, craft etc. in the basement area as mentioned in the other upload with the clarification on various points. The school shall shift these activities to upper floors. School is directed to ensure that no academic and co curricular activity will be conducted in the basement area of the school. It should be out of bounds of students and may only be used for storage. the school shall submit an undertaking to this effect on SARAS within 3months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until

compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
